

Event Participant's Statement due to the COVID-19 epidemic situation

Due to the preventive measures resulting from the threat of SARS-CoV-2 virus, on the basis of guidelines for organizers of cultural and entertainment events during SARS-CoV-2 virus epidemic in Poland issued by the Ministry of Culture, National Heritage and Sports, the Ministry of Development and the Chief Sanitary Inspector:

I, the undersigned

1) hereby declare that, to the best of my knowledge, on the day of the submission of this statement and during the last 14 days preceding the submission:

(a) I am not and I have not been infected with the SARS-CoV-2 virus;

(b) I am not and I have not been under quarantine or under epidemiological surveillance;

2) hereby declare that

- I am vaccinated (please present a vaccination proof)*

3) In case that I develop symptoms of COVID-19 infection within 14 days of the submission of this statement, I undertake to immediately inform the appropriate local sanitary and epidemiological services, as well as the Foundation of the International Chopin Piano Festivals, email address: chopin@festival.pl and to take the necessary steps as indicated by the Chief Sanitary Inspectorate: <https://www.gov.pl/web/koronawirus>.

4) I undertake to observe the Regulations of the sanitary regime on the principles of safe functioning of the Festival during the COVID-19 epidemic being in force within the area of the Frederic Chopin's Manor House (Dworek Chopina).

I hereby give my consent for my personal data provided in this statement to be included in the personal data files of the Foundation of the International Chopin Piano Festivals in Duszniki-Zdrój – for the purpose to be forwarded upon request of the appropriate sanitary services (e.g. Chief Sanitary Inspectorate, ul. Targowa 65, 03-729 Warsaw) in the scope necessary for the epidemiological investigation in case of my infection or detection that I was in direct contact with an infected person, in accordance with the current regulations concerning the prevention, counteracting, and combating of SARS-CoV-2 (COVID-19).

 - a) Article 9(2)(i) in conjunction with Article 6(1)(c) and (e) of the GDPR and the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2018, item 1000, as amended) in connection with Article 17 of the Act of March 2, 2020 on special solutions related to prevention, counteraction and combating of COVID-19, other infectious diseases and crisis situations caused by them (Journal of Laws of 2020, item 374, as amended) - in order to prevent and combat the epidemic caused by SARS-CoV-2 coronavirus;
